

# Executive Summary

The Roadmap for Implementing The Caribbean Priority Actions on the Illicit Proliferation of Firearms and Ammunition across the Caribbean in a Sustainable Manner by 2030 (Caribbean Firearms Roadmap) is a regional initiative endorsed by fifteen Caribbean States and the Dominican Republic that seeks to enhance security and promote sustainable development across the Caribbean region, by addressing the illicit trafficking of firearms and ammunition.<sup>1</sup>

The Caribbean Firearms Roadmap (CFRM) is underpinned by a Monitoring and Evaluation (M&E) Framework, which consists of four overarching goals, specific targets, and Key Performance Indicators (KPIs). These comprise sub-KPIs, which monitor national progress, and macro-KPIs, which capture advancements at the regional level. To monitor progress on the implementation of the CFRM both nationally and regionally, States are required to complete a Baseline Assessment (BA) and submit annual reports.

This Guidance Document provides Caribbean States with a technical tool to adopt the CFRM's M&E Framework and to streamline its reporting process with that of existing international and regional instruments on firearms. By identifying synergies between the different reporting mechanisms, the document helps reduce duplication and improve data collection and reporting efficiency. It assists States in leveraging retrieved data to meet CFRM reporting requirements, thus optimizing efforts and available resources, and ensuring consistency across multiple reporting systems.

The document examines several key international and regional instruments on firearms, along with their reporting mechanisms:

- ▶ The Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons (PoA), its International Tracing Instrument (ITI), and the national reports on their implementation.
- ▶ The Protocol against the Illicit Manufacturing of and Trafficking in Firearms, their Parts and Components and Ammunition (Firearms Protocol) along with the Illicit Arms Flow Questionnaire (IAFQ).
- ▶ The Arms Trade Treaty (ATT), including its Initial and Annual Reports.
- ▶ The Inter-American Convention Against the Illicit Manufacture of and Trafficking in Firearms, Ammunition, Explosives, and Other Related Materials (CIFTA) along with the Questionnaire on the Implementation and Effectiveness of CIFTA.

Additionally, the analysis incorporates Sustainable Development Goal (SDG) 16, specifically indicator 16.4.2, as part of the Complementary Actions of the CFRM, directly supporting the advancement of the 2030 Agenda for Sustainable Development.

For the purpose of this comparison, the reporting templates referred to and analysed in this document are those required for submission in the 2024 reporting year. It is important to note that as these are frequently updated, the findings presented in this document may need to be revised accordingly in the future.

## The Guidance Document is organized into several key sections:

- 1. Introduction** ▶ Sets the context for streamlined reporting in the Caribbean.
- 2. Overview of Reporting Obligations and Requirements** ▶ Reviews reporting requirements under the CFRM and that of relevant international and regional instruments on firearms.
- 3. Mapping Data Collection Effort: Methodology** ▶ Introduces the methodology developed for this Guide, a coding scheme which systematically compares reporting templates and identifies matches. The scheme categorizes the alignment into four categories: Exact Match; Partial Match; Possible Match; and No Match.
- 4. Mapping Data Collection Efforts: Analysis and Results** ▶ Presents the results of the analysis, which indicate that States can leverage existing data collection to meet the reporting requirements under the CFRM.
- 5. Complementary Actions** ▶ Analyses the CFRM's five Priority Actions which support reporting under the 2030 Agenda for Sustainable Development and concludes that data reported under international and regional instruments on firearms can be capitalized on to fulfil reporting on the CFRM's Complementary Actions.
- 6. Key Findings and Strategic Recommendations** ▶ Presents key findings based on the analysis conducted of alignments and gaps between the CFRM M&E Framework and the reporting mechanisms of relevant international and regional instruments.
- 7. Conclusions** ▶ Outlines a clear path forward for the CFRM and M&E focal points to streamline reporting efforts, make the most of data synergies, and foster better coordination between regional and international stakeholders.

Concrete findings of the paper include that 28 items from the CFRM M&E Framework have exact matches with other reporting instruments; 79 items have partial matches, and 255 items have possible matches. Moreover, 3 items from the CFRM's Complementary Actions have a Partial Match, and 3 items have a Possible Match with reporting mechanisms of other instruments. Consequently, the Guiding Document recommends that:

**National data collection efforts under the CFRM M&E Framework should be strategized** to leverage matches found with the reporting mechanisms of relevant international and regional instruments on firearms.



Considering that some of the CFRM's Priority Action items involve systems, databases, or other information-sharing structures facilitated by Implementing Partners of the Roadmap, **States may consider seeking their assistance in retrieving the necessary information.**



**States can synergize data collection efforts** by mapping national focal points and information sources of the relevant international and regional instruments on firearms, which would facilitate data gathering.



**Since not all reporting mechanisms cover a calendar year, data disaggregation maybe be required.** This process could be facilitated by consulting with the relevant national focal points or information sources. States could also consider storing information disaggregated by month, enabling its aggregation as required by each reporting framework.



**States should encourage the development of coordination and information-sharing mechanisms** among focal points of the relevant international and regional firearms instruments. Such mechanisms would streamline reporting processes, reduce the reporting burden, and enhance the quality and consistency of data submitted across the different instruments.



**Special attention should be given to how key concepts are defined across relevant instruments** to ensure the accuracy and usability of the data collected and reported.

# 1. Introduction

The Caribbean Firearms Roadmap (CFRM) is a regional initiative adopted in 2020 with the goal of addressing the illicit trafficking of firearms and ammunition across the Caribbean. Endorsed by fifteen Caribbean States and the Dominican Republic, the CFRM aims to reduce firearm-related crime and violence, enhance security, and strengthen regional cooperation among States that have adopted it.

To ensure effective progress tracking and accountability, the CFRM is supported by a Monitoring and Evaluation (M&E) Framework. This framework consists of 4 overarching goals, 16 associated targets, 101 sub-Key Performance Indicators (KPIs) which track national progress, and 15 macro-KPIs which capture regional advancements. To foster national ownership of the M&E Framework while maintaining alignment with the broader vision of the CFRM, States are only required to report on the sub-KPIs relevant to the Priority Actions identified in their National Action Plans (NAPs), rather than on all 101 sub-KPIs.

Currently, Roadmap States have multiple reporting obligations related to firearms control, each involving potentially different focal points, organizations, critical deadlines, and input formats. Simultaneously, Roadmap Implementation Partners -international and regional organizations committed to supporting CFRM States in implementing the Roadmap- conduct periodic data gathering in the Caribbean, often collecting similar or identical information. Hence, the CFRM's M&E Framework could leverage these existing efforts.

At the third Annual Meeting of States on the CFRM in 2023, representatives highlighted the significance of evidence-based decision making, comprehensive data collection, and the critical

role of M&E in tracking progress.<sup>2</sup> Furthermore, stakeholders were encouraged to sustain collaboration and coordination across the Caribbean, underscoring the need to align reporting efforts to maximize impact.

**Hence, the purpose of this document is to guide States in adopting the CFRM M&E framework and to streamline the CFRM's reporting requirements with that of existing international and regional instruments on firearms control. To achieve this, it analyses the CFRM's Priority Actions and compares them to the reporting obligations outlined in various international and regional instruments, identifying synergies across reporting tools. The document is thus intended as a technical resource for CFRM focal points, M&E focal points, and Implementing Partners.**

## 2. Overview of Reporting Obligations and Requirements

### The Caribbean Firearms Roadmap (CFRM) is structured around four goals:

#### GOAL 1

► Reinforce regulatory frameworks governing firearms and ammunition.

#### GOAL 2

► Reduce the illicit flow of firearms and ammunition into, within, and beyond the region.

#### GOAL 3

► Bolster law enforcement capacity to combat illicit firearms and ammunition trafficking and their illicit possession and misuse.

#### GOAL 4

► Systematically decrease the risk of diversion of firearms and ammunition from government- and non-government-owned arsenals.

Each goal is connected to a set of targets and actions. In essence, the Caribbean Firearms Roadmap serves as a foundational document for States as they develop their individual National Action Plans (NAPs). NAPs outline national priorities, strategies, and specific timelines for implementing the Roadmap at a national level, while also identifying areas where States may require international assistance.

### The Caribbean Firearms Roadmap Monitoring and Evaluation Framework

The Roadmap's M&E framework provides participating States the opportunity to report advances on implementing their NAP under the Roadmap. To facilitate the measurement of progress at both national and regional levels, a comprehensive national baseline process was envisioned. This process aims to gather baseline information and establish a benchmark for future assessments. Each CFRM State is expected to conduct a Baseline Assessment by completing a standard questionnaire. The questions in this assessment are directly aligned with the corresponding sub-KPIs, establishing a starting point from which States can report their annual progress. These sub-KPIs contribute to fifteen macro-KPIs, which assess the status at the regional level, offering a detailed understanding of the situation in the region prior to the implementation of the CFRM.

Once NAPs are approved and Baseline Assessments completed, participating States are required to submit annual reports on their national sub-KPIs and, by extension, the fifteen regional KPIs, which provide quantitative measures of progress. Also included within annual KPI reports are narrative questions that offer more qualitative, outcome-focused data.

This document outlines synergies and offers guidance to focal points and State representatives on locating necessary information for the Baseline Assessment and Annual KPI Reporting templates by comparing these to the reporting forms of relevant international and regional instruments on firearms.


## Relevant International and Regional Instruments on Firearms

This section outlines the instruments used to compare with the CFRM's M&E Framework. It also provides details on the most recent reporting dates and the data submitted by CFRM States through relevant reporting tools and questionnaires.

### The Programme of Action on small arms and its International Tracing Instrument

The Programme of Action to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All Its Aspects (PoA, 2001), and its associated International Tracing Instrument (ITI, 2005)<sup>3</sup> were adopted by all United Nations Member States and requires them to submit a joint report of both instruments every two years. These instruments exhibit uneven levels of reporting by CFRM States. Out of the 15 CFRM States which are also UN Members,<sup>4</sup> 11 have submitted reports since the adoption of the PoA. Globally, there are 198 reports available from 2002 to 2024, with 40 submitted by CFRM States. For 2024, four States –Belize, Haiti, Dominican Republic and Jamaica– have provided reports.

## Firearms Protocol

The Protocol against the Illicit Manufacturing of and Trafficking in Firearms, their Parts and Components and Ammunition (Firearms Protocol), supplementing the UN Convention against Transnational Organized Crime (UNTOC), has 123 State Parties (as of 10 November 2024), including twelve CFRM States.<sup>5</sup>

The implementation of the Firearms Protocol is assessed through a peer review process (UNTOC Review Mechanism). Further, the Conference of Parties mandated UNODC to collect and analyse both quantitative and qualitative data on firearms trafficking, including their parts, components, and ammunition, hence UNODC developed the Illicit Arms Flow Questionnaire (IAFQ), consisting of two questionnaires: the Data and the Metadata files. The reporting period for these questionnaires spans a calendar year and must be submitted annually by State Parties. While the core questions are included in the Data File, the Metadata file provides insights into the scope and nature of the information presented in the Data File.<sup>6</sup>


Reporting under the IAFQ reveals that 10 CFRM States have submitted reports, albeit inconsistently, between 2010 and 2023. The compilation of the figures reported in the IAFQ presented in Tables 3, 4, and 5 exemplify how reporting varies across State, year, and element within the questionnaire.<sup>7</sup> These figures show how this inconsistency plays out, with wide variability in reporting levels: no single CFRM State has consistently submitted entries across years or element in the questionnaire.

**Table 3. Number of firearms seized by CFRM States as reported on the IAFQ - UNODC**





## Arms Trade Treaty

The Arms Trade Treaty (ATT) currently has 116 State Parties, including 14 CFRM States (as of 10 November 2024).<sup>8</sup> The ATT reporting framework comprises Initial and Annual reports, hence this document analyses both types.<sup>9</sup> State Parties must submit their Initial Reports within the first year of their accession to the Treaty, while Annual Reports cover activities from the previous calendar year and are required every year thereafter. Out of the 87 States that have submitted Initial Reports, nine are CFRM States. All nine States submitted their Initial Reports, as reflected in Table 6 below.

Thirteen CFRM States are Parties to the Inter-American Convention Against the Illicit Manufacturing of and Trafficking in Firearms, Ammunition, Explosives, and Other Related Materials (CIFTA). Table 8 below provides details on the dates of signature, accession, and deposit.

At the third Conference of the State Parties to the CIFTA in 2012, State Parties adopted the “Course of Action 2012-2016 for the Operation and Implementation of the CIFTA.”<sup>10</sup> Section 3, item (b) of this document establishes that every two years, State Parties must submit a Questionnaire on the Implementation and Effectiveness of the CIFTA, which collects information on the status of implementation of the Convention. Table 9 details the reporting status of CFRM States under this questionnaire.

### Indicator 16.4.2

Proportion of seized, found or surrendered arms whose illicit origin or context has been traced or established by a competent authority in line with international instruments.

Indicator 16.4.2 of the 2030 Agenda for Sustainable Development seeks to assess the effectiveness of the international community's efforts in combating illicit arms trafficking. It is calculated as:


$$\frac{\text{Number of arms for which the point of diversion was established/identified}}{\text{Total number of arms seized, found and surrendered}}$$

The data required for the above calculation is gathered at a national level by law enforcement and other agencies responsible for firearms issues. Internationally, this information is mainly reported through tables 5.1 to 5.3 of the Firearms Protocol's IAFQ, supplemented by data submitted in the PoA's national reports.

Of the 15 States that adopted the CFRM which are also UN Member States, four –Antigua and Barbuda, Bahamas, Grenada, and Guyana– have reported data for SDG indicator 16.4.2. Notably, the focal points for indicator 16.4.2 in these four States are also the PoA's national points of contact.

## 3. Mapping Data Collection Efforts: Methodology

This chapter outlines the methodology and analytical approach used to identify synergies between the CFRM's M&E Framework and the reporting tools of the relevant international and regional instruments on firearms, as outlined in Table 10. It also details the definitions of the codes used to characterise these synergies.

### Approach to Analysis

Each item within the CFRM's M&E Framework was compared to the items included in the reporting mechanisms of the four relevant instruments to identify alignments in the information they capture. This comparison was conducted in two stages: first, for the items of the Baseline Assessment Reporting Template, and second, for the items within the Annual KPI Reporting Template of the Roadmap. A coding scheme was developed to assess the degree of similarity between pairs. The codes used in this scheme are explained below.

## Coding Scheme: Exact Match

Items within the CFRM's M&E Framework **capturing the same information** that items in the reporting questionnaire of a relevant instrument **were assigned the code "Exact Match."** While the wording of pairs of items may differ, they capture the same core concept. An example of an exact match is outlined in Table 11 below.







## 5. Complementary Actions

The CFRM outlines five Priority Actions in support of the 2030 Agenda, under its “Complementary Actions” section. These Actions focus on establishing and clarifying roles and responsibilities for the development of indicators, the collection of data, and the design of information flows related to Goal 16 (“Promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable and inclusive institutions at all levels”), Target 4 (“By 2030, significantly reduce illicit financial and arms flows, strengthen the recovery and return of stolen assets and combat all forms of organized crime”), indicator 16.4.2 (“16.4.2 Proportion of seized, found or surrendered arms whose illicit origin or context has been traced or established by a competent authority in line with international instruments”).

While the CFRM's M&E Framework does not contain specific items uniquely associated with the Complementary Actions that States are required to report on, CFRM's Actions 3.1.4<sup>14</sup> and 3.2.1<sup>15</sup>, which address data collection and information exchange, are related to the five Complementary Actions.

### Complementary Actions: Exact Matches

No Complementary Actions of the CFRM's M&E Framework have exact matches to any items in the reporting templates of the relevant instruments.

## 6. Key Findings and Strategic Recommendations

Based on the analysis conducted in this document, several key findings and recommendations have emerged regarding the alignment and gaps between the CFRM M&E Framework and the reporting mechanisms of the relevant international and regional instruments. These findings not only highlight areas of synergy but also pinpoint opportunities for improvement in data collection and reporting processes.

### Key finding 1. Strategizing Data Collection Efforts Based on Matches

National data collection efforts for CFRM reporting could be streamlined by aligning them with data collection activities required by reporting obligations of other international and regional instruments on firearms (as detailed in Section 4).

#### Exact Matches

For items in the CFRM's M&E Framework that have exact matches, data needed for past years can be sourced from the relevant report(s) of the corresponding instrument(s), where available. Similarly, future reporting efforts for regional obligations can support CFRM's reporting requirements, and vice versa.

#### Partial Matches

For items in the CFRM's M&E Framework with partial matches, relevant questions can be partially answered using data provided in the specific items of the reporting mechanisms of the relevant instrument(s). Complementary efforts could focus on retrieving remaining information requested within the items with partial matches, such as by contacting the focal points or sources associated with the relevant instrument(s).

#### Possible Matches

For possible matches, responses from specific items in the reporting questionnaires of the relevant instruments which match with item(s) from the CFRM's M&E Framework could be reviewed to determine if any data would apply to the corresponding items in the CFRM's M&E Framework. As with partial matches, efforts can focus on obtaining the remaining information by contacting the relevant focal point or information sources.

#### No Matches

For items in the CFRM's M&E Framework with no matches, efforts could focus on identifying relevant data sources and retrieving the necessary information.

### Key finding 2. Identifying Focal Points and Data Sources

The questionnaires of the relevant instruments on firearms contain items focused on identifying national focal points or points of contact responsible for reporting obligations or requirements. **States can therefore synergize data collection efforts by referring to the focal points and information sources detailed in the reporting questionnaires of the relevant international and regional instruments on firearms, thereby facilitating more efficient data gathering.** Table 27 below lists the item numbers from each questionnaire of each relevant instrument that cover information on focal points or points of contact.

### Key finding 3. Developing Coordination and Information-sharing Mechanisms for Focal Points

In addition to communicating with national focal points or information sources for the regional and international instruments, the development of coordination and information-sharing mechanisms among these and CFRM focal points may also prove beneficial. In this regard, working with focal points across the different instruments to standardize procedures, share reporting templates and harmonize data collection could help streamline the different processes, easing the burden which often comes with reporting, while improving the quality and consistency of data submitted across instruments. This mechanism could also facilitate

regular joint reviews and updates to ensure continuous improvement in data collection and reporting efficiency.

## Key finding 4. Leveraging the Work Done by Implementing Partners

**Considering that some of the CFRM's Priority Action items involve systems, databases, or other information-sharing structures managed by Roadmap Implementing Partners,<sup>17</sup> States may consider leveraging the expertise and resources of these partners to retrieve the necessary information.** An example of an information-sharing database and the organization that manages it is provided in Table 28 below.

## Key finding 5. Considering Reporting Periods and Years

There is variation in the reporting periods across the reporting mechanisms of the relevant international and regional instruments on firearms. For instance, the Questionnaire on the Implementation and Effectiveness of CIFTA has a biennial reporting timeline, whereas the CFRM's M&E Framework mandates annual reporting. Therefore, **it is important to consider these differences when retrieving and utilizing information from reports.** Relevant national focal points and information sources could be contacted. Additionally, where feasible, States may wish to collect and store information in a disaggregated format, organized by month. This approach would enable focal points of the relevant instruments to easily aggregate data as required by each reporting framework.

## Key finding 6. Considering Definitions of Key Concepts

Key concepts may be measured and reported differently across the relevant reporting instruments depending on how they are defined. For example, States or organisations within a State may adopt a different definition of the term "firearms" or they may define it differently from the definition used in a relevant reporting instrument. Furthermore, data captured on the same concept may vary across instruments due to these definitional differences. **To ensure accuracy, usability and comparability of the reported data, it is recommended that efforts be made to align the data collected with the definitions provided in each reporting instrument.** If alignment is not feasible, it is encouraged to clearly specify the definitions used, such as in sections designated for additional information, comments, or remarks. Additionally, **when interpreting the matches identified in this document, definitions should be considered, as they impact the degree of alignment.**

# 7. Conclusion

## 7. Conclusion

This Guidance Document analysed potential synergies between the CFRM M&E Framework and existing reporting obligations contained in relevant international and regional instruments on firearms, such as the PoA/ITI, the Firearms Protocol, the ATT, and CIFTA. By comparing the reporting mechanism of the CFRM with that of these instruments, the document identified areas of overlap, opportunities for data sharing, and gaps in the current systems.

The findings demonstrate varying levels of alignment, ranging from exact matches to no matches. These results highlight the potential for improving and streamlining data collection and reporting processes across the region.

As the CFRM continues to be implemented across the region, the actionable recommendations and strategies outlined provide a clear pathway towards more efficient, comprehensive, and integrated data collection efforts. These enhancements will support evidence-based decision-making and drive progress in combating illicit arms and ammunition trafficking at national and regional levels.

Moving forward, States should leverage the identified synergies, while addressing gaps to create a more unified and integrated approach to reporting and implementation under these frameworks. The collaboration with Roadmap Implementing Partners is thereby considered vital.

**AS THE CFRM CONTINUES TO BE IMPLEMENTED ACROSS THE REGION, THE ACTIONABLE RECOMMENDATIONS AND STRATEGIES OUTLINED PROVIDE A CLEAR PATHWAY TOWARDS MORE EFFICIENT, COMPREHENSIVE, AND INTEGRATED DATA COLLECTION EFFORTS.**
